3.0 Treasury Report (Zoubeida Ounaies)

Ounaies stated that the Committee depends on donations from industry. She acknowledged donors and members Marcelo Dapino, Mary Frecker, Dimitris Lagoudas and Kara Peters (who donated their registration waiver to the Committee.) She also thanked Ephraim Garcia for transferring \$2k into the Committee's account (Anderson Award, etc.)

3.2 Fundraising subcommittee report (Greg Washington)

Meetings were held to discuss finances. (i) Current situation/fundraising (ii) Fundraising request of Aerospace Division, and (iii) Fundraising request of individual members (ppt attached) SMASIS conference – conference revenue used to pay the fees. Profit split 80/20 with 20% going to Aerospace Division.

Proposal 1 – Aerospace Division’s portion to be split 70/30 with the ASMS TC, with 30% going to the Aerospace Division. The 70% component will be used to build an endowment.

Proposal 2 – The ASMS TC will request \$20k from the Division (\$12k for award endowment); \$6k for general committee support; \$3k for future ASMS TC Conference Fund Account

E. Garcia – Aero Division wants to set money aside for the TC to grow the fund and is preserved (custodial funds)

C. Lynch – ASME encouraging Divisions to take an entrepreneurial approach; ASME is willing to give the TC the 80% funds to see the TC grow

Proposal 3 – TC requests conference attendees to donate \$25 as part of the Pioneer’s banquet (primarily used to support the awards)

D. Brei – Funds not be tied to Pioneer’s banquet

M. Frecker – Emphasize that money is to build an endowment

N. Wereley – Issue with people paying with university funds not being able to donate (whereas dues might be ok)

M. Frecker - Endow all awards. Proposal #1 amended to reflect this.

There was a vote on the 3 proposals – All members voted in favor.
